# Meeting with Ann Lorenzo and Hillary Hollis of DDS

The meeting between Ann Lorenzo, Hillary Hollis, Daniel Rajczyk, and Eva Rajczyk was held on April 27, 2015 at Salvatore's Restaurant in Lawrence, MA. The basis of the meeting was to introduce AWorks to DDS and to find out what, if anything, DDS can do for us.

The ASD department of DDS is brand new with only two employees: Ann and Hillary. Both Ann and Hillary were very excited about what AWorks will have to offer the Merrimack Valley Community in the near future. We discussed the implementation of the new law (see <u>http://aspergerworks.org/frequently-askedquestions/commission-help-asd-people</u>), which was responsible for the ASD department at DDS. Ann mentioned that as far as they understand it funding through their department is available for all adults on the Spectrum who had been diagnosed prior to their 18th birthday. Daniel pointed out that if that is correct, there would be no financial help available for those who, like him, were diagnosed as adults. Both women assured him that they will look into the matter and assured the AWorks representatives that they will lobby to make changes in the law to reflect the needs of our potential clients. Additionally, they invited Daniel to speak to members of DDS about AWorks and about the needs of adults on the Spectrum, especially those of adults diagnosed with Asperger's.

It appears that adults on the Spectrum can receive up to \$25,000 a year in financial assistance from the department. Their clients are expected to self-advocate (clients/families are their own agents). For instance, the Agency can suggested that they could get services with AWorks. Once they (the clients or families) decide to "hire" AWorks, ASD at DDS provides them with the necessary funds.

In order to know how much we would need to charge, we have to come up with a formal proposal. The proposal needs to include salaries, administration fees, cost of office space, etc. For instance, usually job coaches are hired on an hourly basis

at \$15.00 per hour, working with each client approximately 1 hour three days a week.

The meeting was basically a brainstorming session with many ideas emanating from Ann and Hillary.

## Meeting with June Cowen Sauvageau and Meghan McCann of <u>Northeastern Independent Living Program</u>

Daniel Rajczyk and Eva Rajczyk met with June Sauvageau, Executive Director, and Meghan McCann, Quality Project Manager, of NILP on May 7, 2015. Both June and Meghan were anxious to meet with us. As a result, we had a very productive meeting. June explained that their primary focus is transitioning young adults (ages 16 to 22) from school to the workplace and/or college. They would like to form an informal partnership with us through which they would provide our clients (customers)

- Independent living skills training
- Employment readiness training
- Core services, such as skills training (resume writing, etc.)

## We would provide

- Job coaching/mentoring that is so needed and unavailable at this time
- Employer reach-out / Employer "training"
- Available jobs for our clients

Additionally, we would be able to apply for certain grants jointly, since many grant givers like to see partnerships and/or cooperation between service providers.

They also offered to help us out by providing us the use of their meeting room for our monthly meetings and for our up- coming Aspie Support Group meetings at their offices (Northeast Independent Living Center, 22 Ballard Street, Lawrence, MA).

June invited Daniel to attend the next monthly Executive Directors Round Table discussion at Jericho Road. This group is made up of EDs of local non-profits. June felt that Daniel could benefit from inclusion in this group for two reasons:

- 1. To enable him to work with other non-profit EDs
- 2. To network and advertise Asperger Works

Daniel expressed the idea that perhaps there would be someone in this group who could mentor him about the ins-and-outs of being an ED, a job he understands in theory but which he is unsure of when it comes to actual performance since he had never help such a position before. June was sure that at least one member of the group would help him out.

We were told that each year NILP receives an Entrepreneurship Grant that provides internship opportunities for minimum 15 to maximum of 25 young adults. Here, too, we could profit since

NILP needs to place these young people with area employers, of which we would be one. Training sessions will be starting this month after completion of which, internship placement will take place. Daniel immediately put in a request for an intern who would be interested in working as Daniel's executive secretary.

It was decided that Meghan will be our contact person at NILP, since June is often on the road and difficult to get hold of.

It was suggested that we should get in touch with the <u>Mental Health and Human (DMH)</u> <u>Transition Age Youth Initiative</u> program to let them know of our existence and to give them information about the services we intend to provide. It appears that there are more and more students are identified on the Autism Spectrum; so there will be increased need for our services.

Additionally, it was recommended that we get in touch with <u>Beacon Health Strategies</u> and Susan Cooper of GIC's EAP Coordinator (they will give us the contact information).

Another topic of discussion was the role of the family once there are enough non-family Members on the Board. It was suggested that the family should form a foundation thereby remaining involved in Asperger Works but in a more informal way.

Meghan indicated that she may want to become an AWorks Board Member but has not yet made any definite commitment.

NIPL is expanding physically and are in the midst of construction. Depending on how much space their organization needs, they might be able to give us some office space to begin providing services.

At the end of our formal meeting, June and Meghan took us around the office and introduced us to people in different departments, all of whom were quite excited about our organization.
