1. Date of Event: October 16

2. **Time**: 7:00 – 11:00

3. Tickets

- a. No tickets will be sold at the door. All tickets must be purchased in advance.
- b. Cost of tickets -- Tentative (depends on what Elks will charge for hall rental and cost of food):
  - i. \$50 per person
  - ii. \$150 family of four
  - iii. \$450 for a table of 10
  - iv. 1 table reserved for people on the Spectrum \$25 each
- c. Tickets must be purchased two or three weeks ahead of event (We will need to check with caterer to see when he/she needs to know the number of people attending.)

#### 4. Entertainment
