- 1. Daniel Rajczyk reported that we purchased a General and Directors and Staff Liability Insurance from the Philadelphia Insurance Company.
- 2. As soon as we have an intern and volunteers, we need to also buy Workman's Comp., which is not at all expensive.

# **COMMERCIAL SECURITIES AGREEMENT - LOAN**

Adam Rajczyk reported that, at the suggestion of Marion Donahue, VP with Pentucket Bank, we should apply for a loan for \$10,000. This will be very helpful once we hire a job coach since the CDBG program won't kick in until after we have paid out the person's salary.

#### **PRESS RELEASE**

It was agreed that Andrew DeCarlo will come up with talking points for a press release regarding our obtaining office space and send it to Eva Rajczyk. Once the press release is reviewed by all Board and Advisory members, it will be disseminated to various newspapers, etc.

# JOB COACH POSITION

- The following changes were made in the position description:
  - o There should be no certificate requirement
  - Change wording to AS/BA preferred
  - o Add Bi-lingual helpful
- Daniel Rajczyk made a motion to accept the changes. It was seconded by Adam Rajczyk. The motion carried unanimously.
- It was agreed that we should form an interview committee.
- We agreed that we will market the job in LinkedIn, Craig's List, Monster, Facebook, on our Website, etc. It was also agreed that we would put up flyers in area colleges advertising the job.

 Andrew DeCarlo volunteered to come up with some challenging screening questions to be given to candidate at time of interview
