Presentation Update

- Eva Rajczyk reported that she contacted 40 companies in the Greater Merrimack Valley area and beyond and succeeded in making presentations to 35, most on Zoom and a few in person.

 Aspies, especially if they indicate that they are affiliated with us.
- Transportation may be an issue for some Aspies. Tom Wood will send information about transportation available to people with disabilities in New Hampshire and Lisa Rajczyk will do the same for our area.

 - Need Competent Workforce? Hire an Aspie
 - Employers, the Key to Aspie Success
