 - Richard Rodriguez and Eva Rajczyk met with Mr. Bonet on January 19, 2023
 - Meeting lasted about 1 hour

- Mr. Bonet very supportive because he has someone in his family who is on the Autism Spectrum
- Suggested partnering with MassHire
- Autism Care Partner Open House report by Eva Rajczyk
 - Company moved from Methuen
 - They provide ABA program for young children
 - Although they were pleased to meet AWorks reps (Adam, Daniel, Eva Rajczyk, Richard Rodriguez, & Tom Wood), it is difficult to see what kind of relationship we can develop with them
- WeCare365 AFC (Adult Foster Care) grant report by Adam Rajczyk
 - We received a grant donation of \$1000 through efforts of City of Lawrence
 especially that of Mayor Brian DePeña, & Richard Rodriguez
 - Organization works with adults (starting at 16) needing extra support by providing "caregivers and member families with financial relief and... comprehensive services."
 - Possibility of partnership
- Dinner of Hope 2023 Group discussion
 - Possible date: October 14 (Eva Rajczyk will make arrangements with Maria's)
 - Tom Wood will contact potential award recipients from the autism community
 - Eva Rajczyk proposed having the mayors of Lawrence and Haverhill give a short speech (maximum 5 minutes).
 - It was decided that Board members will try to find well-know members of the Greater Boston community (possibly with some connection to autism) as our keynote speaker
 - Businesses need to be contacted ASAP
 - Sponsorship
